- c) Photo identity card (Voters Id/Adhar/Passport/Driving license/PAN card etc...)
- d) Training/Experience certificate.
- e) Challan signed by postal authority and postal receipt.
- f) Acknowledgement obtained at the time of submission of online application.
- g) Other relevant certificates as claimed.
- h) Candidates who are in service shall submit a No Objection Certificate from their employer.
- i) Candidates claiming Caste/Category/ other reservations have to produce following certificates in the prescribed format as per orders/guidelines of Govt. of Karnataka.
