2. Submission of application:

The On-line application shall be submitted in the prescribed format available in KPCL website <http://www.karnatakapower.com>. **Application in any other form will not be considered.**

Application Fee (Non-refundable):

- a] Rs.500/- (Rs.250/- for SC/ST/Cat-I candidates) plus postal service charges of Rs.15/-.
- b] Nominal fees of Rs.50/-(Rs.35/- processing charges+Rs.15/- postal service charges) for :
 - i. Ex-serviceman;
 - ii. Children of Defence Personnel killed or disabled in action;
 - iii. Persons with Disability (Divyanga)

Mode of payment:

- Application fee is payable through any **Post Office branch which is computerized, in the state of Karnataka**. A format of challan is generated after filling up of online application in website and the same can be downloaded and amount remitted in Post Office.

3. Age Limit:

III. **Pension** : As per 'New Defined Contributory Pension Scheme' effective from 01.01.2012.

5. Probation/Minimum Service/Postings:

- The selected candidates will be posted to Thermal Power Stations located in Raichur and Bellary Districts. They will be on probation for a Period of 12 months.
- Selected Candidates will have to give an undertaking on a Non-Judicial Stamp paper of ₹200/- [Rupees Two Hundred Only] stating that he/she will serve the company continuously for a minimum period of 5 years from the date of report.
- Selected candidates shall give an undertaking that they will work in project areas for a minimum period of 10 years.
- The Candidates selected for the post of Junior Engineers & Chemical Supervisors who possess higher qualification than the prescribed qualification, their claim for higher post will not be considered for elevation under the Elevation Scheme up to 5 years as per existing C&R rules.

6. Selection procedure:

- a) Selection will be made purely on merit basis duly following reservation policy.
- b) Merit list will be prepared based on the marks obtained in the written test.

7. Written Test:

A Written Test for 100 marks will be conducted in the relevant technical subjects. Questions will be of objective type with OMR sheet.

The question papers will be in English version in respect of engineering cadres only whereas for Chemists/Chemical Supervisors the question paper will be in both Kannada & English.

- Candidates will have to attend the written test in any one of the following 6 centers:

1. Bengaluru
2. Ballary
3. Belagavi
4. Kalaburgi
5. Mysuru
6. Shivamogga

- Candidates may indicate any **two centers** in the order of their preference. In case of inability to consider their options nearest test center to the preferred center will be allotted.
- Candidates applying for more than one post will have to choose the same centers.

8. Kannada Language Test:

- Those who have not studied Kannada as one of the subjects in SSLC or equivalent examination are required to pass a Kannada Language Test.
- Candidates who pass the Kannada Language test are only eligible to be considered for selection process.
- Date and venue of Kannada language test will be published separately in KPCL Website.

9. Verification of Documents:
