Karnataka Power Corporation Ltd invites bids through GOK e-procurement platform www.eproc.karnataka.gov.in from the bidders having adequate financial resources, state of the art technology, suitable for Supply/erection of equipment and technical man power with sufficient past experience in executing similar works and who satisfy prescribed pre-qualification requirements for supply, erection, testing and commissioning of complete Fire Protection, Fire Alarm and Spray System for the scope of work as detailed below for the proposed Green Building with LEED facilitation at Site No.3, Survey No.13/3, KPCL New office complex inside the Drugs Controller's office premises at Palace Road, Bangalore-560 001 in Karnataka State.

Note: The scope of the work is only indicative. Detailed scope is described in the bid document which is binding on all the bidders.

1.0 INSTRUCTIONS REGARDING (E- PROCUREMENT)

- 1.01 The bid is to be submitted in the GOK e-procurement platform www.eproc.karnataka.gov.in system only.
- 1.02 Bidders, who have not registered in e-procurement portal, may do so by registering through web site www.eproc.karnataka.gov.in.

- 1.03 The bidders can access and download bid documents on the web site, fill them and submit the completed bid documents in to electronic tender on the website itself within the stipulated date. The blank bid documents can be accessed through e-procurement portal web site www.eproc.karnataka.gov.in.
- 1.04 Bidders shall attach scanned copies of all the certificates pertaining to the pre-qualification requirement as mentioned under “Minimum qualification requirements” clause. Whenever required, bidders shall furnish the original certificates to the KPCL authorities, failing which, the bidder will be disqualified.
- 1.05 Conditional bids, incomplete bids without EMD, bids not properly uploaded and late submission of bids shall be rejected.
- 1.06 Bidders shall refrain from altering/modifying/revising the price bids after the date and time fixed for submission of bids in the calendar of events even though if it is accepted by the portal. Bids submitted within the scheduled date and time shall only be eligible for further processing of the bids. Any bid submitted after the date and time specified shall be rejected even if it is accepted by the e-portal. Date and time stamp of the e-portal system shall be final in deciding the time of submission of bid. Decision of the Corporation in this regard shall be final.

2.0 MINIMUM PRE-QUALIFYING REQUIREMENTS

- 2.01 The intending bidder should have satisfactorily commenced and completed as a prime contractor for at least one similar works of value not less than 2.30 crs during the preceding five years i.e., 2010-11 to 2014-15.
- 2.02 The intending bidder should have a minimum financial annual turnover of not less than Rs.6 Crs in any of the two years of preceding five years.
- 2.03 The intending bidder shall not have been subject to forfeiture of EMD/foreclosure/termination of their contract in KPCL/government or any other utility and have not been blacklisted for participation in tender issued by KPCL or government or any other utility in India during the past 5 years.

The intending bidder shall fulfill all the qualifying requirements as indicated above. The qualifying requirement as claimed by the bidder shall be filled up in the format enclosed.

- 3.0 **THE TENDER IS OF TWO COVER SYSTEM.** The Bidder should upload scanned copies of the following documents through e-procurement portal only.

A. COVER-I (Technical Bid)

- 3.01 The intending bidder shall furnish the relevant work done certificates, on letter head with Corporate Identification Number, signed by competent authority certifying that the bidder has satisfactorily supplied, installed and completed the system in respect of paras Sl.Nos.2.01 above.
- 3.02 For financial qualifying requirement, Copies of audited P&L Account / audited balance sheet for the preceding five completed financial years. i.e.,

2010-11 to 2014-15 duly certified by the Chartered Accountant to establish annual turnover requirement stipulated under para no. 2.02 above.

- 3.03 Annexure D: The notarized declaration by the bidder that none of his contracts have been subject to forfeiture of EMD/foreclosure/termination of their Contract in KPCL/Government or any other utility and blacklisted for participating in tender by KPCL or Government or any other utility in India during the past five years.
- 3.04 Scanned copy of the BG towards EMD in KPCL format as per ANNEXURE - B along with BG verification check list ANNEXURE - E.
- 3.05 Form of Bid (ANNEXURE – A) duly signed as per format enclosed.
- 3.06 The bidder shall sign and upload scanned copy of the details of service tax applicable duly filled as per format ANNEXURE – H enclosed.
- 3.07 All the technical details and drawings, etc of the technical offer along with all the technical particulars.
- 3.08 Upload duly filled and signed copies of all the schedules F1 to F7 as per the format enclosed
- 3.09 The bidder shall upload scanned copies of following documents:-
 - a. Income tax – Pan No.
 - b. VAT registration certificate
 - c. Independent PF code
 - d. Service tax Registration certificate
 - e. Labour certificate

B. COVER-II (Price Bid)

Price schedule (Price Bid). Upload signed and scanned copies of Price schedule strictly as per the enclosed format only.

- 4 The bidder shall quote in Indian Rupees only.
- 5 The intending Bidders shall upload all the documents along with the application.
- 6 Bids (both Cover-1 & 2) must be **electronically submitted** within the date and time published in e-procurement portal. On the date of opening of the bid, Cover-1 of Tender will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the office of the Chief Engineer (Thermal-Designs), KPCL, Sudarshan Complex, 22/23, second Floor, Sheshadri Road, Bangalore-560009. Cover 1 will be opened first, document furnished will be scrutinized to determine the bidders meeting qualifying criteria. The date of opening of the cover-II would be intimated in advance to those bidders who are qualified.

8 **BID VALIDITY:** The validity of the bid shall be 180 days from the date of opening of the Technical bid (Cover-I) or extended period.

9 **EARNEST MONEY DEPOSIT:**

9.01 **EMD : Rs. 4.20/- lakhs.** The e-payment shall be made for Rs. 1.0/- lakh (direct debit, credit card & National Electronic Fund Transfer (NEFT) or Over The Counter (OTC) only through ICICI Bank and remaining **Rs.3.2/- lakhs** (Three lakh twenty thousand) either in the form of crossed demand draft in favor of KARNATAKA POWER CORPORATION LIMITED, payable at Bangalore or through Bank Guarantee from the Nationalised / Schedule Bank on Rs 200/- stamp paper as per the KPCL Proforma. The original BG shall be submitted to undersigned in person or by the post on or before the date and time of opening of technical bid. KPCL shall not responsible for loss in transit or any postal delay.

9.02 The Bank Guarantee submitted towards EMD shall be valid for a period of 210 **days** from scheduled last date of submission of bid. In case, the validity of the Bid is required to be extended, the validity of the BG furnished towards EMD shall be extended up to **30 days** beyond such extended bid validity period. Only on receipt of full EMD of Rs.4.20/- lakhs along with technical bid, Price bid will be opened and considered for evaluation.

9.03 The EMD furnished by unsuccessful bidders will be returned, only after the award of contract and entering in to agreement with the successful bidder. For the successful bidder, the EMD will be returned, only after he enters into contract agreement and furnishes the contract performance guarantee in an acceptable form.

- 9.04 The EMD furnished by the bidders will be forfeited in case the bidder withdraws the offer during the validity or violates any clause stipulated in the bid.
- 9.05 No interest is payable to the bidders for the Earnest Money Deposit.
- 10 **Contract Performance Guarantee:** For the due and faithful performance of the Contract, the successful bidder shall be required to furnish a performance guarantee (Security Deposit) of 10% of the Contract value in the form of Bank Guarantee (by any Scheduled or Nationalised Bank) on a non-judicial Stamp paper of Rs. 200/- only. The Bank Guarantee shall be strictly as per the format enclosed and should be furnished within 20 days after the issue of LOA. The Bank guarantee shall be valid for the entire period of the Contract. The Performance Guarantee will be returned to the Contractor on successful performance of the Contract after the expiry of guarantee period. No request for furnishing reduced Bank guarantee will be considered. No interest is payable on the Contract Performance Guarantee. The contractor shall extend the Bank Guarantee towards Security deposit beyond the stipulated Guarantee period, if necessary. In case defects are notified during the Guarantee period, the Bank Guarantee shall be valid till such time the defects are rectified and performance of the equipment is satisfactory for a further period of twelve months from the date of replacement/rectification of such defects or the original guarantee period, whichever is later. Security deposit will be treated as to have been paid only after the Bank Guarantee furnished by the Contractor is accepted by the Corporation in writing.
- 11 **COMPLETION PERIOD:** Completion period is 8 (Eight) calendar months including monsoon from the date of issue of LOA for the entire scope of work as specified elsewhere in the bid document.
- 12 KPCL reserves the right to accept or reject any or all the bids, without assigning any reason thereof. However the reasons for rejection will be recorded as per KTPP Act.
- 13 Bids with stipulations for settlement of dispute by reference to arbitration shall be liable for rejection. The bids containing conditions whatsoever will be liable for rejection.
- 14 Any agency whose performance in the ongoing projects of KPCL is observed to be not satisfactory such agency shall be liable for rejection.
- 15 KPCL reserves the right to verify any information / documents furnished by the bidder, should the circumstances so warrant in the overall interest of Corporation. The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification. In case the information or the documents furnished are found to be incorrect or invalid, then the EMD furnished by such bidders will be forfeited.
- 16 Part and incomplete bids / Telegraphic bid / bids not accompanied with EMD / belated bids will not be accepted.

- 17 The prospective bidder should not coerce any other bidders to derail the healthy and competitive bidding process. The prospective bidder shall not resort to anti-competitive practices like price rigging, cartelization, ring formation or adopt unfair practices both civil and criminal aimed at preventing other bidders from quoting for the bid, any act inhibits competition or any act that will be detrimental to the interest of the Karnataka Power Corporation Limited. If the bidder is found to have resorted to such practices as specified above, he and others who act in concert with him shall be debarred from quoting for this bid and for future bids for a further period of three years. Such acts entail the disqualification for participating in the tender process.
