1.0 Sealed BIDS in two parts are invited for the work of “ **Repair, Re-Conditioning, Testing and commissioning of Static Heat Run Equipment (D.C Rectifier Set 0-60V /5000A) at Bhadra Generating Station, KPCL, B.R. Project, - 577115, Shimoga- Dist, Karnataka**” from reputed bidders with proven track record of successful completion of similar works.

### 2.0 BRIEF SCOPE OF WORK:

The brief scope of work covers, Repair, Re-Conditioning, Testing and commissioning of Static Heat Run Equipment (D.C Rectifier Set 0-60V /5000A) consisting of Control Transformer-cum-Control Panel and Loading Transformer-cum-Rectifier Unit at Bhadra Generating Station.

The capacity of the unit is 5000Amps D.C at an output of 60Volts i.e., 300kW.

### 3.0 THE BIDDERS SHALL HAVE THE FOLLOWING PRE-QUALIFYING REQUIREMENTS:

- a. The bidder shall be a regular contractor/agency/firm and shall have proven experience in the field of repair/reconditioning of the transformers/rectifiers to power utilities/reputed organizations. In proof of the above, work order/purchase order /work completion certificates copies should be furnished.
- b. The Bidders in the last five financial years should have achieved in at least two financial years an average annual financial turnover of Rs.05.00 lakhs. In proof Annual Report/turn over certificates duly certified by chartered accountant shall be furnished.
- c. Bidder shall have PF registration, IT PAN No, VAT No/ Service Tax Registration certificates. In proof, PF registration, IT PAN No, VAT No/ Service Tax Registration certificates copies shall be furnished.
- d. The bid of the bidders whose contracts have been terminated/ foreclosed in KPCL or elsewhere during last 05 years and also those who do not meet the above prequalifying requirement will be rejected.
