The period of contract will be for an initial period of two year from 01.10.2016 to 31.09.2018 the day when the letter of commencement is issued in this regard, which shall be treated for all practical purposes as the date of the commencement of the contract. The contract shall be further extendable for one year or such period as KPCL deems fit. The criteria for extension shall be purely the performance of the contractor during the initial contractual period of two year. The said extendable period shall purely be the discretion of KPCL and at the same terms and conditions.

- 3. Eligibility Criteria: Firms must provide information and provide documents as evidence:-
- i] Bidder must be in business of providing services for hiring of vehicle for the last 3 years. [2013-14, 14-15, 15-16]
- ii] Must have travel and transport as its nature of business [certificate to this effect if available].
- iii] Bidder must have fleet of vehicles at his disposal and must be in a position to attend the emergency situation by arranging alternative vehicle.

- iv] Experience in providing services for hiring of vehicle in at least one State/Central Govt./PSU/Pvt Ltd Co.
- v] Firm must have service Tax Registration No. and Authority with whom registered.
- vi] Firm must have permanent Account Number for Income Tax[PAN].
- vii] Firm must provide details of registered office [Address] with Telephone No. /Mobile No.
- viii] Firm must provide details of Address for communication along with Phone No./Mobile No.
- ix] The bidder should have adequate number of vehicle of the same model to meet the requirement of KPCL.(The vehicles must not be older than 2015)

4. Instructions for Bidders:-

- i] In case of the application being made by a partnership firm, a copy of partnership Deed is required to be submitted along with the tender.
- ii] In case of the application being made by a Private Limited Company, a copy of the Certificate of Incorporation from the Registrar of Companies, Memorandum and Articles of Association of the company is required to be submitted.
- iii] The tender shall be submitted through e-procurement portal only. by 04.00 PM on 22.09.2016.
- iv] It is the responsibility of the Bidders to see that the completed bidding documents are submitted by the specified time and date.
- v] The bid shall consist of two cover system which will consist of 'Technical Bid and Financial Bid'.
- vi] Tenders:[Cover -1 & cover-2] must be electronically submitted, within the date and time published in e- procurement portal. Tender will be opened at prescribed time and date in the e-procurement portal.

- **5.** BID VALIDITY: The validity of the bid shall be 180 days from the date of opening of the Technical bid [cover-I] or extended period.
- **6.** Earnest Money Deposit:
 - i] EMD:Rs 50,000/-.

The e-payment shall be made for Rs. 50,000/-. direct debit, credit card & National Electronic Fund Transfer [NEFT] of Over The Counter [OTC] only through AXIS Bank in favour of KARNATAKA POWER CORPORATION LIMITED

- ii] Part and incomplete bids / bids not accompanied with EMD / belated bids will not be accepted.
- **7.** The successful bidder has to furnish security deposit in the form of Bank Guarantee from a Scheduled Bank towards Contract performance, equivalent to 5% of the contract value with an appropriate validity period as per contract agreement.
- **8.** Bid documents cannot be accessed by such of the Bidders whose EMD has been forfeited or contracts have been terminated or foreclosed, on account of their default in KPCL of elsewhere, during the past 5[five] years. The bidder shall give declaration that EMD has not been forfeited and none of his contracts have been terminated /foreclosed on account of their default in KPCL or elsewhere during the past 5 [five] years.
- **9.** The prospective bidder should not coerce any other bidders to derail the healthy and competitive bidding process. Such acts entail the disqualification for participating in the tender process.
- **10.** The prospective bidder shall not resort to anti-competitive practices like price rigging, cartelization, ring formation or adopt unfair practices both civil and criminal aimed at preventing other bidders from quoting for the bid, any act inhibits competition or any act that will be detrimental to the interest of the Karnataka Power Corporation Limited. If the bidder is found to have resorted to such practices as specified above, he and others who act in concert with him shall be debarred from quoting for this bid and for future bids for a further period of three years.
- **11.** KPCL reserves the right to verify any information/documents furnished by the bidder, the circumstances so warrant in the overall interest of Corporation. In case the information or the documents furnished are found to be incorrect or invalid, then such bids will be rejected and EMD furnished by such bidders will be forfeited.

General terms and conditions

- 1. The contract shall be for the period of two year. The contract may be extended by kpcl mutual understanding for a period of one year subject to satisfaction of the service provided during contract period.
- 2. Right to accept or Reject: KPCL shall not be bound to accept the lowest or any tender and reserves to itself right to accept or reject any bid or to accept whole or a portion of tender, as it may deem fit. Without assigning any reason there of and without incurring any liability to the affected bidder'(s) for the action of KPCL.
- 3. Bidder shall furnish the documents as per in Annexures-"I", "II" and "III".
- 4. Annexures-"I", "II" for Technical bid and Annexure "III" for Financial Bid.
- **5.** Bidder will enter into agreement within one week of being called upon to do so and bear all expenses including charges for stamps etc.
- **6.** The driver should be well conversant of roads in Karnataka, The driver(s) should come on duty before time. If required by KPCL alternate driver will be provided by the bidder. The driver should obey the instructions of the officer authorized by the KPCL in this regard and should have valid driving license during the period of contract.
- **7.** The agency should abide by all statutory requirements for running the vehicle on contract and KPCL will in no way be liable towards taxes, fee, penalties, cost of fuel, and salary to drivers, maintenance or any other charges payable except the contract price, parking charges and toll tax, if any.
- **8.** The vehicle should have necessary permit from the transport Dept./ Authority.KPCL will not be responsible for any challan, loss, damage and accident to the vehicle or any other vehicle or injury to anybody, attracted by the statutory laws such as MVC act workmen's compensation act etc...
- **9.** The vehicle on hire shall be available at all time including Saturdays, Sundays and public holidays or whenever required in case of emergent official work.
- 10. The contractor should have enough resources to repair their vehicles in minimum possible time. When required, they should be in a position to substitute/ replace or arrange extra vehicle at very short notices. In case the vehicle is found not to be in working condition, it shall be returned for immediate replacement. In case no replacement is provided on time, this office would have a right to hire a vehicle from the market and the additional cost incurred by this office will be borne by the contractor.
- **11.**The A/C Vehicle should have functional A/C and in case the same is not in working condition, the rates shall be reduced by 5% from the bill for no-performance.
- **12.**Contractor shall comply all statutory Acts, labour laws,/ regulations/motor vehicle Act contract labour act etc.
- **13.** All legal obligations which include insurance, pollution control, road tax & other Compliances shall be compiled by the contractor & KPCL will not own any responsibility in this regard.

- **14.** The billing will be done on submission of invoices. Bill should be neatly typed and submitted in duplicate, in connection with the service to this office. Payment will be made within 1 month from the receipt of bill, clear in all respect through cheque only. TDS shall be deducted as per govt. order/statutory requirement.
- **15.** The driver should not be normally changed unless requested by the using officer or due to weekly rest to the driver.
- **16.** The vehicle should have the comprehensive insurance of vehicle, driver and passengers ect. to cover the risk during the contract period. In case of any accident, all the claims arising out of it shall met by the contractor and no claim whatsoever shall be borne by KPCL.
- **17.** In case of any dispute of any kind and in any respect whatsoever, the decision of Director [HR] / General Manager [A&HR],KPCL shall be final binding.
- **18.** The contractor shall/ can engage any sub-contractor but cannot transfer the contract to any other person.
- **19.** The fuel tank of the vehicle is to be kept full of which shall be sufficient for at least 250 kms per day. Time consumed/mileage required for intermediate refilling shall not be taken into account.
- 20. The contractor shall provide a log book in which contractor's driver shall ensure that travel particulars such as departure time of vehicle from one to another, time of arrival at destination, the kms covered for the journey, etc. are entered correctly and signed by the officer travelling in the vehicle. The log book with the entries duly completed should be submitted to the officer-in-charge along with the bill at the end of every month. In case, the signatures mentioned above are obtained, such journey will not be counted for the purpose of payment. If during any particular trip, it is noticed that the driver has not met the time schedule given to him or that he has caused inconvenience to the official, penalty clauses will be invoked.

The decision of KPCL on all types of penalties shall be final and binding on the firm.

- **22.** In case for any reason, the commercial vehicle is not provided, the liability of not providing such vehicle and running any other vehicle with the service provider only.
- **23. Fuel price variation clause:** in case of increase / decrease in the price of fuel, the hire charge per km shall be varied as under.
 - Base price in respect of Diesel is to be ascertained as on the date of submission of the bid. The agency shall furnish the base price.
 - For payment of price variation bills, documentary evidence for increase in the price of Diesel is to be produced for verification along with the bills.
 - The variation shall be regulated as under.
 - Increase / decrease in hire charge per km (R1) = (P1 P) / K.

P: Base price of Diesel at the time of quoting the rate.

P1: Revised price of Diesel

K: Mileage of the vehicle i.e. number of KM's vehicle runs per liter of Diesel.
