1.00 Tenders in two parts are invited through e-procurement portal for *Dismantling of existing* 350 NB Motor operated cast steel gate valves, Supply, erection & commissioning of new 350 NB Motor operated cast steel gate valves -2 Nos. for Nagihari Power House from reputed bidders with proven track record of successful completion of similar works.

2.00 Instructions regarding (e-Procurement)

- ➤ The Bid has to be submitted in the Govt. of Karnataka e-procurement portal website only. i.e., www.eproc.karnataka.gov.in
- ➤ Bidders who have not registered in e-procurement portal, may do so by registering through website www.eproc.karnataka.gov.in
- ➤ Pre-qualified bidders can access the bid document on website, fill & submit the completed bid documents into electronic tender on website itself within stipulated date. Blank bid documents can be accessed through e-procurement portal website www.eproc.karnataka.gov.in
- ➤ Bidders shall attach scanned copies of all certificates pertaining to pre-qualification requirement as mentioned under minimum qualifying requirements clause. Whenever required, bidders shall furnish the original certificates to KPCL authorities, failing which the bidder will be disqualified.
- ➤ Conditional bids, incomplete bids, bids without EMD, bids not uploaded properly and late submission of bids shall be rejected.
- ➤ Bidders shall refrain from altering/modifying/revising the price bids after the date & time fixed for submission of bids in calendar of events, even though it is accepted by the portal. Date & time stamp of portal shall be final in deciding time & date of submission of bid. Decision of the Corporation in this regard is final and acceptable to all the bids.

3.00 Earnest Money Deposit

EMD of Rs.50,000.00 (Rupees fifty thousand only) shall be paid online through e-procurement portal using any of the payment modes such as Credit card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the counter (OTC).

4.00 Tender Processing Fee

Payment towards Tender processing fee (As per e-proc. portal) can be made through Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC). Transaction fee is non-refundable.

5.00 Brief scope of work

Dismantling of existing 350 NB Motor operated cast steel gate valves, Supply, erection & commissioning of new 350 NB Motor operated cast steel gate valves -2 Nos. for Nagjhari Power House, covering all associated works and components required for successful completion of the work. Detailed scope is described in bid document which is a binding on all the bidders.

6.00 Pre-qualification requirements:

The bidders shall have the following pre-qualifying requirements:

- 1. The bidder shall be a regular manufacturer/supplier of motor operated cast steel gate valves & must have designed, manufactured, supplied and erected at least 2 (two) Nos. of 200 NB & above capacity motor operated cast steel gate valves to any Power Generating station or any other utility in India which have been in satisfactory operation for at least two consecutive years in the preceding five financial years.
- 2. The work should be executed by themselves & not through their subcontractors. Bidders who are not directly awarded the contract & worked as sub-contractors to other contractors are not eligible to participate in the bid.
- 3. Bidder shall furnish copy of satisfactory performance report issued by the competent authority of power stations or utility certifying performance of the valves supplied & commissioned by the bidder & copies of purchase orders / work orders with reference to the previous similar work done by the contractor.
- 4. The Agency should have annual turnover of at least Rs.50.00 lakhs in the last three years. The agency should furnish annual turnover report duly signed by Chartered accountant during the preceding three financial years i.e., 2011-12, 2012-13 & 2013-14.
- 5. Those bidders whose contracts have been terminated / fore-closed by KPCL or whose performance has not been satisfactory while executing the contract of the above within last ten years are not eligible to participate in the bid. The bidder shall furnish an undertaking in this regard.

- 6. The bidder shall also upload scanned copies of the following statutory documents.
 - (a) Income tax PAN.
 - (b) K.VAT registration certificate
 - (c) Independent PF code registration.
 - (d) Service tax registration certificate.

Note: The original statutory documents shall be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.

7.00 The tender shall be submitted in TWO PART only (Two cover system)

- > Part-I shall consist of pre-qualification, technical details, necessary documents & EMD.
- ➤ Part-II shall consist of financial bid.
- 8.00 The intending Bidders shall upload all the documents along with the tender.
- **9.00** After evaluation of technical bid, those offers which meet PQR & technical specification of the tender in complete manner will be accepted & financial bids of only such bidders will be opened.

11.00 Validity of Bid

The bid shall be valid for 180 days from the date of opening of Part-II (Financial bid) or extended period till the bids are evaluated and it is left to the discretion of NIT authority.

12.00 Successful bidder shall furnish a Bank Guarantee from Scheduled Bank towards contract performance, equivalent to 10% of contract value with an appropriate validity period (including guarantee/warranty period in addition to completion period of work envisaged), while executing contract agreement. BG shall be furnished in prescribed format only.

- **13.00** Bid with stipulation for settlement of disputes by reference to arbitration is not acceptable.
- **14.00** The prospective bidder should not coerce any other bidders to derail the healthy and competitive bidding process. Such acts entail the disqualification for participating in the tender process.
- **15.00** The prospective bidder shall not resort to anti-competitive practices like prices gigging, cartelization, ring formation/adopt unfair practices both civil and criminal aimed at preventing other bidders from quoting for the bid / any act inhibits competition / any act that will be detrimental to the interest of Karnataka Power Corporation Limited. If the bidder is found to have resorted to such practices as specified above, he and others who act in concert with him shall be debarred from quoting for this bid and future bids for a further period of three years.
- **16.00** KPCL reserves the right to verify any information/documents furnished by bidders, should the circumstances so warrant in overall interest of Corporation. In case, the information / documents furnished are found to be incorrect/ invalid, then, EMD furnished by such bidders will be forfeited.
- **17.00** KPCL reserves the right to accept or reject any or all the bids, without assigning any reason thereof. However the reasons for rejection will be recorded as per KTPP Act.
