- C. The bidder should have the following Registration with statutory Departments. Agency should furnish Xerox copy of Certificates along with technical bid. On demand Original shall be produced for verification
  - a) Proof / Certificate for having executed works of similar nature or any IP surveillance work.

- d) Labour Registration Certificate issued by Department of labour.
- e) PAN & latest Income Tax returns filed during the last two financial year
- f) Service Tax registration certificate.
