- 1.0 THE CHIEF ENGINEER (ELECTRICAL DESIGNS) Invites bids from the qualified bidders for the "Design, Engineering, Supply, erection, testing & commissioning of 2 Nos. of LVRT compatible 250KW inverters at 3 MW Solar PV Plant, Yalesandra, Kolar district".
- 2.0 Pre-qualification criteria & bid documents may be downloaded from Government of Karnataka e-procurement website https:/eproc.karnataka.gov.in under login for contractors.
- 3.0 After login to Contractors, please scroll down to the right side bottom to see list of tenders, please click there to find the details of NIT & download copy of the tender. The tender can be downloaded from the portal as per prescribed date & time published in the portal. Only interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable.

# 4.0 EARNEST MONEY DEPOSIT (EMD)

An Earnest Money Deposit for an amount of Rs 76,000 /-( Seventy six thousand only) as indicated in the Notice inviting bids and/ or Brief bid notification shall accompany each bid as detailed in following paragraphs:

- 4.01 Earnest Money Deposit of Rs 76,000 /-(Seventy six thousand only) shall be paid online through e-Procurement portal using any of the following payment modes:
  - a. Credit Card,
  - b. Direct Debit,
  - c. National Electronic Fund Transfer (NEFT),

- d. Over the Counter (OTC) (only through designated branches of ICICI Bank).
- 4.02 Bids not accompanied by the requisite EMD shall be summarily rejected.
- 4.03 If the bidder withdraws his bid before the expiry of the bid validity period prescribed in the bid specification or if the successful bidder fails to submit the contract performance guarantee as specified in the bid & or fail to enter into a contract with the Corporation in the form prescribed with related requirement within 30 days of the date of letter of award, the bid guarantee will be forfeited as liquidated damages.
- 4.04 The EMD furnished by unsuccessful bidders will be returned, only after the award of contract & entering in to agreement with the successful bidder.
- 4.05 For the successful bidder, the EMD will be returned, only after he enters into contract agreement & furnishes the contract performance guarantee (Security Deposit) in an acceptable form.
- 4.06 No interest is payable to the bidders for the Earnest Money Deposit.
- 5.0 Tenders (both Cover-I & II) must be **electronically submitted** (online through internet) within the date & time published in e-procurement portal. Cover-I of Tender will be opened at prescribed time & date in the e-procurement portal, in presence of the Tenderers who wish to attend at the office of the Chief Engineer (Electrical Designs), KPCL, Sudarshan Complex, 22/23, Third Floor, Sheshadri Road, Bengaluru-560 009. Opening of Cover-II shall be intimated later.

## 8.0 Eligibility Criteria:

- 8.1 The intending bidder shall satisfy the pre-qualification requirements as stipulated below:
  - a. Bidder should have successfully supplied & installed Power conditioning Units of 250 kW and above to any one Solar PV Power plants of MW scale in India and the same shall be in satisfactory operation continuously for a minimum period of 1 year during the last 5 years, reckoned from the date of issue of NIT. Satisfactory completion certificate issued from State/ Central Government undertaking/any utility from officers not below the rank of Executive Engineer/ equivalent cadre/ Competent authority/ Project head shall be furnished. If required Copy of the work order for corresponding works shall be furnished during tender evaluation process.
  - b. Bidder during the last five financial year period shall have achieved average annual turnover of Rs 40.00 Lakhs for at least two financial years. As proof of the above, the audited balance sheet counter signed by Chartered accountant shall be furnished.
- 8.2 The intending bidder shall furnish the following documentary evidence to substantiate the qualification requirement specified above for the fulfilment, which is prerequisite for opening of cover-2 containing the price bid.
  - i) Satisfactory performance certificate is to be furnished to satisfy the condition above. Satisfactory completion certificate issued from State/ Central Government undertaking/any utility from officers not below the rank of Executive Engineer/ equivalent cadre/ Competent authority/ Project head of respective solar

- plant certifying the performance of the solar plant shall be furnished.
- ii) Bidder during the last five financial year period shall have achieved average annual turnover of Rs 40.00 Lakhs for at least two financial years (2012-13, 2013-14, 2014-15, 2015-16 & 2016-17). As proof of the above, the audited balance sheet counter signed by Chartered accountant shall be furnished to satisfy the condition above.
- 8.3 Those bidders whose EMDs are forfeited/contracts have been terminated/foreclosed by KPCL or elsewhere or whose performance has not been found satisfactory while executing contracts with KPCL or elsewhere during the last 05 years are not eligible to bid. The Bidder shall give declaration (Schedule-09) that EMD has not been forfeited & none of his contracts have been terminated /foreclosed on account of their default in KPCL or elsewhere during the last 05 years. (Declaration by the bidder shall be duly signed by the Notary & uploaded in the e-portal).
- 9.0 Tenderers shall not be under declaration of ineligibility for corrupt & fraudulent practices issued by the Government of Karnataka.
- 10.0 The tender is of two cover system.The Bidder should upload scanned copies of the following documents:

## A. COVER-I (Technical Bid)

- a) Documents to meet the qualification criteria specified in NIT.
- b) The notarized declaration by the bidder that none of his contracts have been subject to forfeiture of EMD/foreclosure/ termination of their Contract in KPCL/Government or any other utility & blacklisted for participating in tender by KPCL or Government or any other utility in India during the past five years (Refer schedule-09).
- c) Details of the Commercial terms & conditions, all the schedules specified in bid documents pertaining to commercial terms & conditions. All the technical details etc., of the technical offer along with all the technical particulars.

# B. COVER-II (Price Bid)

Price schedule only (Price Bid).

11.0 Bids submitted within the scheduled date & time shall only be eligible for further processing of the bids. Any bid submitted after the date & time specified shall be rejected even if it is accepted by the e-portal. Date & time stamp of the e-portal system shall be final in deciding the

time of submission of bid. Decision of the Corporation in this regard shall be final & acceptable to all the bidders.

- 12.0 The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 13.0 Rates shall be quoted in price schedule i.e. Price bid, in the e-procurement portal only in the space provided for uploading "FINANCIAL BID DOCUMENTS".
- 14.0 Price bid of tenderers who have furnished all the documents to meet the qualification criteria, technically & commercially responsive will only be opened.
- 15.0 The tender shall be valid for 180 days from the date of opening of 'Cover-I' of the bid.
- 16.0 KPCL reserves the right to verify any information/documents furnished by the bidder. In case the information or the documents furnished are found to be incorrect/false or invalid then the EMD furnished by such bidder shall be forfeited.
- 17.0 Corporation reserves the Right to reject any or all the tenders without assigning any reasons. However, in all cases KTPP act shall be followed.
- 18.0 Any other information required may be obtained from the office of the undersigned during office hours.
- 19.0 Bidders who have not obtained the user ID & Password for participating in e-procurement in Karnataka Power Corporation Limited may now obtain the same from the website (https:/eproc.karnataka.gov.in).
