The agency other than BHEL shall be a sub vender of M/s BHEL/NTPC registered vender. The intended bidder shall furnish the sub vender certificate/Code.
- The intending bidder other than BHEL should have executed similar type of work at a value of **Rs.4.50** lakhs in a single work order during any one of the last five years i.e from 2012-13 to 2016-17 and work order/ work done certificate shall be certified by competent authority not below the rank of Executive engineer.
- Average annual financial turnover shall be **Rs.9.00** Lakhs or more in any Two of the previous Five Financial years i.e. 2012-13 to 2016-17. Certified copy of statement of accounts issued by chartered accountant shall be enclosed as documentary evidence.
