**1.0** The Chief Engineer (Electrical Designs) invites bids in English from the qualified bidders for the design, engineering, manufacture, quality surveillance, testing at supplier's works, transportation, delivery on FOR destination basis, arranging transit insurance, Dismantling and Buyback of existing system, erection, testing & commissioning of **Static excitation systems with Digital automatic voltage regulator and associated equipments complete for 3x50MW+3x40MW Generating units of Kadra & Kodasalli Power Houses"**.

**2.0** **Pre-qualification criteria & bid documents may be downloaded from Government of Karnataka e-procurement website <https://eproc.karnataka.gov.in> under login for contractors.**

After login to Contractors in the e-portal, please scroll down to the right side bottom to see List of tenders, please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only interested Bidders who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable.

**3.0** Tenders must be accompanied by Earnest Money Deposit (EMD) which should be paid online through e-Procurement portal using any of the following payment modes at the time of submission of bids. Bidder shall

remit Rs. 10,50,000/- (Rupees ten lakh fifty thousand only) in one of the following payment modes:

**PAYMENT MODE - A**

- 3.1 Credit Card
- 3.2 Direct Debit
- 3.3 National Electronic Fund Transfer (NEFT)
- 3.4 Over the Counter (OTC) (only through designated branches of Axis Bank)

- 4.0 The tender is of two cover system. Bidder shall submit documents to satisfy the pre-qualification criteria and Tenders (both Cover-1 & 2) electronically (online through internet) within the date and time published in e-procurement portal.

The Bidder should upload scanned copies of the following documents.

**A. COVER-I (Technical Bid)**

- a) Documents to meet the qualification criteria specified in NIT.
- b) The declaration by the bidder that none of his contracts have been subject to forfeiture of EMD/foreclosure/termination of their Contract in KPCL/Government or any other utility and blacklisted for participating in tender by KPCL or Government or any other utility in India during the past five years (**Refer schedule-17**).
- c) Details of the Commercial terms and conditions, all the schedules specified in bid documents pertaining to commercial terms and conditions. All the technical details and drawings, etc of the technical offer along with all the technical particulars.

**B. COVER-II (Price Bid)**

Price schedule only. (Price Bid -Schedule 9A&9B). The price quoted for supply shall include the cost of buyback of existing excitation equipments. The successful bidder shall furnish the cost considered for buyback to the corporation, if required.

- 5.0 Tenders (both Cover-1 & 2) must be electronically submitted (online through internet) within the date and time published in e-procurement portal. Cover-1 of the tender will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the office of the Chief Engineer (Elecl-Designs), KPCL, Sudharshan Complex, 22/23, Third Floor, Sheshadri Road, Bangalore-560009. Opening of Cover-2 shall be intimated later.

- 6.0 Brief scope of tender is as follows. Other details can be seen in the tender documents.

The bidder shall quote for full quantity of equipments in the tender, failing which the bid is liable for rejection.

- 7.0 Earnest Money Deposit (EMD):** Earnest Money Deposit of **Rs 10,50,000/- (Rupees Ten lakhs fifty thousand only)** which should be paid online through e-Procurement portal for the tender shall be in any of the above payment modes indicated under Clause 3.0. The EMD shall be valid for 210 days from the date of bid opening.

**9.0 Minimum qualification requirements:**

- (i) The bidder must be a manufacturer who have designed, supplied and commissioned at least 3 (three) numbers of micro-Processor based static excitation system with DAVR and associated equipment complete for generating units of 50 MW or above capacity in India which have been in satisfactory operation for at least two consecutive years in the preceding five years.
- (ii) Intending bidder shall have a minimum financial turnover of not less than Rs.14.0 Crores (Rupees Fourteen Crores only) at least two financial years in the last five years.
- (iii) The intending bidder shall not have been subject to forfeiture of EMD/foreclosure/termination of their Contract in KPCL/Government or any other utility and shall not have been blacklisted for participating in tender by KPCL or Government or any other utility in India during the past five years.

The intending bidder shall furnish the following documentary evidence to substantiate the qualification requirement specified above, the fulfillment of which is prerequisite for opening of cover-2 containing the price bid:

- i. Performance certificates signed by an officer of the rank of Chief Engineer or Station Superintendent/ competent authority of power stations certifying the satisfactory performance of the equipment supplied by the bidder for at least two consecutive years in the preceding five years.
- ii. Annual financial statements or reports duly certified by the chartered accountant for at least two financial years in the last five years to establish the minimum financial turnover requirement stipulated.
- iii. The intending bidder shall not have been subject to forfeiture of EMD/foreclosure/termination of their Contract in KPCL/Government or any other utility and shall not have been blacklisted for participating in tender by KPCL or Government or any other utility in India during the past five years. Bidder shall furnish the notarized declaration in this regard as specified in the schedules of the bid. (Declaration by the bidder shall be duly signed by the Notary and uploaded in the e-portal as per the schedule specified).
- iv. Furnish quality assurance plan adopted.

**10.0** Tenderers shall not be under declaration of ineligibility for corrupt and fraudulent practices issued by the Government of Karnataka.

- 11.0 Bids submitted within the scheduled date and time shall only be eligible for further processing of the bids. Any bid submitted after the date and time specified shall be rejected even if it is accepted by the e-portal. Date and time stamp of the e-portal system shall be final in deciding the time of submission of bid. Decision of the Corporation in this regard shall be final and acceptable to all the bidders.
- 12.0 The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 13.0 Rates shall be quoted in price schedule (Schedule – 9A&9B i.e Price bid) in the e-procurement portal only
- 14.0 Price bid of tenderers who satisfy minimum qualification criteria in the NIT, technically and commercially responsive will only be opened.
- 15.0 The tender shall be valid for 180 days from the date of opening of Cover-1 of the bid.
- 16.0 **Delivery period:** Delivery period shall be 24 weeks from the date of letter of award or detailed order whichever is earlier.
- 17.0 KPCL reserves the right to verify any information/documents furnished by the bidder should the circumstances so warrant. In case the information or the documents furnished are found to be incorrect/false or invalid then the EMD furnished by such bidder shall be forfeited.
- 18.0 Corporation reserves the Right to reject any or all the tenders without assigning any reasons. However, in all cases KTPP act shall be followed.
- 19.0 Any other information required may be obtained from the office of the undersigned during office hours.
- 20.0 Bidders who have not obtained the user ID and Password for participating in e-procurement in Karnataka Power Corporation Limited may now obtain the same from the website (<https://eproc.karnataka.gov.in>).
