### Description of the work:

“Servicing of compressors, blowers, under truck equipment's and air brake systems of Locomotives” for a period of four months.

### Important Dates:

1. Last date for receipt of quotations/offers:- 29/06/2018, 15.00 Hrs
2. Opening date of sealed quotations:- 29/06/2018, 15.30 Hrs

The sealed quotations shall be superscripted with enquiry no. and date, date of opening of the quotations. Bidders/Agencies shall invariably furnish valid GSTIN along with Quotations/Offers (With Valid HSN/SAC codes). Offers without valid GSTIN and HSN codes will not be considered for evaluation.

### Pre-qualification requirements:

1. The bidder should have experience in carrying out maintenance works/jobs of locomotives of BHEL/Indian railways or any other make. Shall submit documentary proof of job orders and certificates of satisfactory completion.
2. Agencies having valid BHEL/Any Gov. organisations/ Reputed Private organizations, issued letter as consultants of locomotives repair and maintenance jobs.
3. Firm/individual/partnership registration, GSTIN certificates.
4. The bidders shall submit EARNEST MONEY DEPOSIT, 2.5% of the quoted value in the form of DD/BG drawn in favour of Deputy General Manager (Finance)- BT, BTPS, Karnataka Power Corporation Limited, Kudathini - 583152, from any nationalised / Scheduled Bank with minimum validity of 3(Three) months in a separate sealed cover.

### Terms and conditions:

1. It shall be the responsibility of the bidder to furnish all the particulars which are required for due consideration of the tender though not mentioned in the specification.
2. Tender validity shall be 180 days from the date specified from the last date of submission of the tender.
3. The bidders are advised to pursue all the clauses in the specification and the instructions before quoting.

4. Any the clarifications if required shall be got cleared by the bidder, clarification and information given by the 'Engineer' or his employees or his representatives shall not in any way be binding on KPCL.
5. Price quoted by the Bidders shall be firm/fixed during the bidder's performance of the contract and not subject to any variation on any account. Applicable taxes and duties as on last date of submission of bid. Taxes, duties etc., subsequently enforced / collectable at the future date shall be borne by the corporation. Any variation in Taxes, duties, royalties etc., upward / downward shall be paid / recovered. All payments towards variation in taxes, duties etc., shall be on production of documentary proof. The Income Tax, etc., which are deductible as per statutes in force in Karnataka State/India will be deducted by the corporation at the applicable rates from time to time from the bills/invoices raised by the contractor.
6. The contract period should be for 04 months from the date of issue of work order OR utilization of schedule-B quantity, whichever is earlier. The agency shall carry out all the works round the clock on all days including Sundays, general holidays during the period of contract. During emergency, the agency shall attend the work on intimation and work round the clock.
7. The agency shall arrange all the necessary, general tools and tackles required to carry out the work at his own cost.
8. All the work shall be carried out under direction and satisfaction of the Engineer. Not withstanding the fact that clearance or approval has been given by the Engineer; the bidder shall be responsible for the correction of positions, dimensions and the quality of workmanship.
9. In the event of occurrence of any accidents at/near the site of work or in connection with execution of the work, a report shall be submitted by the contractor immediately to the Engineer giving full details of the accident. He shall also report such accidents to all competent authorities wherever such reports are required by them. Any violation will entail penalties as indicated in the safety manual.
10. The agency shall provide all required safety personal protective equipment to carry out the works and adhere all safety norms as per Factory Act
11. The schedule / scope of work is liable to alteration by way of deletions or additions at the discretion of the corporation.
12. The Chief Engineer (FM)BTPS or authorized officers of the corporation shall have the power, from time to time, in the execution of the work, to issue notice in writing and to instruct/direct the contractor to make alterations / variations in the work.
13. The quantities shown in Schedule–B are tentative and liable for change. The payment shall be made only to the items that are operated.
14. No advance payment is entertained. On successful completion of works, the contractor shall submit bills on pro-rate basis with all documents to Executive Engineer (CHP)M-2, BTPS who in turn inspect the works, verifies the bills, certifies and arrange the payment after observing KPCL payment procedures. 100% Payment will be made within 30 days from the date of receipt of invoice. All the payment related to this contract shall be made by the Deputy General Manager (Finance) at BTPS, Kudathini, Bellary.
15. The successful bidder shall execute a contract agreement on a stamp paper, purchased in Karnataka, of value of Rs.200.00 only in the form prescribed by the Engineer within twenty days from the date of receipt of the work order.
16. The performance guarantees security deposit not applicable.
17. Any suit or proceedings arising in any respect under this contract shall be subject to jurisdiction in law courts at Bellary, Karnataka only.

## Scope of work and Schedule-B

### **01. Servicing of blowers (02No's) and compressors (02No's)**

- a. Greasing to all blower bearings.
- b. Checking blowers and compressors belt tightens if required tightening the belt.
- c. Checking blowers and compressor fasteners tightens if required tightening the fasteners.
- d. Cleaning of blowers and compressors.
- e. compressor oil servo 150 top up if required.
- f. Checking the alignment of blower's pulley and compressors pulley related to traction generator pulley if required alignment as to be made.

### **02. Servicing of air brake system.**

- a. Replacement of worn out brake pads with new ones and brake tightening work.
- b. Cleaning and maintenance of pneumatic kit.
- c. Arresting any air leakage in pneumatic kit, air brake systems and pipelines.
- d. checking the operation of J-1 safety valve at 7.5 kg/cm<sup>2</sup> if not operating servicing of J-1 safety valve as to be made or replace with new one.
- e. 8"X6" Duplex brake cylinder overall and refit if required.
- f. 1-1/4"check valve checking if required change with new one.
- g. SA-09 independent Brake valve overall and refit
- h. replacement of damaged air brake system hoses
- i. checking the operation of locomotive hand brake if required adjustment as to be made.
- j. Trail Run of the Locomotives for performance test

### **03. Servicing of under truck equipment's**

- a. Tightening of all under truck fasteners and replacing worn out fasteners with new one
- b. Renewing of all consumables like bull gear servo coat 140, traction motor bearing oil servo68.
- c. Side buffer greasing and fasteners, split pin tightening & adjustment.
- d. C.B. Coupler / Draw gear arrangement greasing and fasteners, split pin tightening & adjustment.
