 - b) The Bidders in the last five financial years should have achieved in at least two financial years an average annual financial turnover of **Rs.16.70 Lakh**. In proof, Annual Report/turn over certificates duly certified by chartered accountant shall be furnished.
 - c) Bidder shall have Independent PF registration No., IT-PAN No, GST No. and Class I Electrical license. In proof PF registration certificate, IT-PAN card, GST Registration certificate, Class I Electrical license copies shall be furnished.
