BRIEF TENDER NOTIFICATION

1.0 Sealed BIDS in two parts are invited for the work of “ **Machining work of spare slip ring assembly (collector assembly) of Sharavathy Generating Station**” from reputed bidders with proven track record of successful completion of similar works.

2.0 BRIEF SCOPE OF WORK:

Scope of work includes (i) enlarging the slots (58mmX12mmX30mm) to (60mmX20mmX30mm) provided for DC leads(6 nos. in top ring & 3 nos. in bottom ring) and also providing 4 nos. threaded hole fin assembly for fixing eye bolts for slings/belts during lifting. (ii) Arranging two way transportation, insurance, e- way bill, indemnity bond.

3.0 THE BIDDERS SHALL HAVE THE FOLLOWING PRE-QUALIFYING REQUIREMENTS:

- I. The Bidder shall be a manufacture/agency/contractor and shall have proven experiences in the field of executing machining of heavy metal components using CNC machines in specialized workshops. In proof of the above, purchase order/work order and Invoice copy/work completion certificate copies for at least one single order of similar works with the contract value not less than Rs.79,000.00 issued from competent authority should be furnished.
- II. The Bidders in the last five financial years should have achieved in at least two financial years an average annual financial turnover of Rs.1.57 Lakh. In proof, Annual Report/turn over certificates duly certified by chartered accountant shall be furnished.
- III. Bidder shall have IT PAN No, GST Registration number. In proof IT PAN No, GST Registration certificates copies shall be furnished.
- IV. The bid of the bidders whose contracts have been terminated/ foreclosed in KPCL or elsewhere during last 05 years and also those who do not meet the above pre-qualifying requirement will be rejected.

If Demand draft is drawn from the bank other than State Bank of India then Demand draft collection charges of **Rs.200/- (Rupees Two Hundred Only)** shall be added to Earnest Money Deposit (EMD) value. Tender not accompanied with requisite EMD will be rejected.


