- 3 **TERMS OF PAYMENT** : 100% Payment with full taxes & duties as per actuals after receipt and acceptance of materials at site. If any other mode of payment is insisted/mentioned by the supplier, corporation reserves the right of loading the additional cost to arrive at the landed cost which may please be noted.
- 4 **QUANTITY** : The quantity mentioned in the enquiry is subjected to variation depending on the final requirements and Purchase order condition.
- 5 **GUARANTEE / WARRANTY** : The materials shall be guaranteed for a period of 12 months from the date of commissioning or 18 months from the date of dispatch whichever is earlier against manufacturing defects/bad workmanship.  - 9** TRANSPORT : Material Shall be insured & transported only through reputed transporters who have godown at Raichur/Yeramarus Like Associated Road Carriers, TCI, SER etc.
 - 10** EARNEST MONEY DEPOSIT: If the quoted value (inclusive of all taxes and duties) is more than Rs.1,00,000.00(One Lakh) then 1% of the quoted value shall be furnished in the form of DD/BG drawn in favour of Assistant General Manager (Finance), YTPS,Raichur Power Corporation Limited, Yeramarus - 584 134, from any nationalised / Scheduled Bank (payable at SBI/ Syndicate Shakthinagara) with minimum validity of 3(Three) months in a separate sealed cover.
