**Sub: “Design, engineering, manufacture, quality surveillance, testing at works, supply, transportation to site, storage at site, local intra-site transportation, erection, testing and commissioning, performance guarantee tests and handing over of one No. of VIP lift of 680Kgs/ 10 Passengers capacity of Unit-4 and one No. of Freight lift of 1500Kgs capacity of Unit-5&6 including dismantling and Buyback of existing lifts, civil and electrical works, certification etc.,” – reg.**

**1.0** Chief Engineer (Thermal Designs) invites bids from the qualified bidders for the design, engineering, manufacture, quality surveillance, testing at works, supply, transportation to site, storage at site, local intra-site transportation, erection, testing and commissioning, performance guarantee tests and handing over of one No. of VIP lift of 680Kgs/ 10 Passengers capacity of Unit-4 and one No. of Freight lift of 1500Kgs capacity of Unit-5&6 including dismantling and Buyback of existing lifts, civil and electrical works, certification etc., at RTPS, Raichur district, Karnataka.

**2.0** Pre-qualification criteria & bid documents may be downloaded from Government of Karnataka e-procurement website <https://eproc.karnataka.gov.in> under login for contractors.

After login to Contractors, please scroll down to the right side bottom to see list of tenders, please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only interested bidders who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable.

**3.0** Earnest Money Deposit (EMD):

An Earnest Money Deposit for an amount of Rs.1,26,550/-(Rupees One lakh twenty six thousand five hundred and fifty only) as indicated in the Notice inviting bids and/ or Brief bid notification shall accompany the bid as detailed in following paragraphs:

- 3.01 Earnest Money Deposit of Rs.1,26,550/- (Rupees One lakh twenty six thousand five hundred and fifty only) shall be paid online through e-Procurement portal using any of the following payment modes.
- Credit Card
  - Direct Debit
  - National Electronic Fund Transfer (NEFT)
  - Over the Counter (OTC) (only through designated branches of Axis Bank)
- 3.02 Bids not accompanied by the requisite EMD shall be summarily rejected
- 3.03 If the bidder withdraws his bid before the expiry of the bid validity period prescribed in the bid specification or if the successful bidder fails to submit the contract performance guarantee as specified in the bid and or fail to enter into a contract with the Corporation in the form prescribed with related requirement within 15 days of the date of letter of award, the bid guarantee will be forfeited as liquidated damages.
- 3.04 The EMD furnished by unsuccessful bidders will be returned, only after the award of contract and entering in to agreement with the successful bidder.
- 3.05 For the successful bidder, the EMD will be returned, only after he enters into contract agreement and furnishes the contract performance guarantee (Security Deposit) in an acceptable form.
- 3.06 No interest is payable to the bidders for the Earnest Money Deposit.
- 4.0** Tenders (both Part-1 & 2) must be **electronically submitted** (online through internet) within the date and time published in e-procurement portal. Part-1of tender will be opened at prescribed time and date in the e-procurement portal, in the presence of the tenderers who wish to attend at the office of the Chief Engineer (Thermal Designs), KPCL, Sudarshan Complex, 22/23, Second Floor, Sheshadri Road, Bangalore-560009. Opening of Part-2 shall be intimated later.
- 5.0** Brief scope of tender is as follows. Other details can be seen in the tender documents.

The bidder shall quote for both VIP lift & freight lift as per schedule 3. The total price of VIP lift & freight lift after deducting buyback value shall be considered for evaluation in order to determine L1 bidder. If the bidder fails to quote for both the items (i.e. VIP lift & freight lift), the bids shall be treated as non-responsive since it does not cover entire scope of works and will be liable for rejection.

## 7.0 Eligibility Criteria:

7.1 The intending bidder shall satisfy the pre-qualification requirements as stipulated below:

1. The Bidder should have executed similar work, in the last five preceding financial years (i.e. 2018-2019, 2017-2018, 2016-2017, 2015-2016 and 2014-2015) successfully for a minimum value of Rs.32 lakhs for retrofitting works of VIP/passenger lift and freight lift involving “dismantling old lifts (both civil and electrical works), Supply, Erection, testing & commissioning of new lifts”. As a proof, the pertinent work order copies of value of Rs. 32 lakhs & above and work done certificates for satisfactory execution of works shall be furnished.
2. As a proof of Technical experience/competence and in support of the above said work at S1.No.1, the Bidder should submit at least one performance certificate of the lift, which is functional for minimum two years, carried out by him, issued by the end user by competent authority not below the rank of Chief Engineer or Project Head.
3. The bidder should have achieved, in his name, at least two financial years an average annual financial turnover of Rs.64 lakhs during the preceding five financial years (2018-2019, 2017-2018, 2016-2017, 2015-2016 and 2014-2015). As a proof of this, the bidder shall furnish Balance sheet and Profit & Loss Account Statements duly certified by a Chartered Accountant for the corresponding years.

- 7.2 The bidder shall furnish the following documentary evidence to substantiate pre-qualification requirement in part-1 of the bid:
- i) As a proof for having carried out the similar works, the work order copies of value of Rs. 32 lakhs & above and work done certificates for satisfactory execution of works shall be furnished.
  - ii) As a proof of Technical experience/competence, the Bidder should submit at least one performance certificate in last five preceding financial years (i.e. 2018-2019, 2017-2018, 2016-2017, 2015-2016 and 2014-2015),, which is functional for minimum two years, carried out by him, issued by the end user by competent authority not below the rank of Chief Engineer or Project Head.
  - iii) As a proof of financial qualifying requirement, the Bidder shall furnish Balance sheet and Profit & Loss Account Statements for the preceding five financial years (2018-2019, 2017-2018, 2016-2017, 2015-2016 and 2014-2015) duly certified by a Chartered Accountant to establish annual turnover requirement stipulated above along with PF registration and Name, address along with the state name and GSTIN or UIN.
  - iv) Furnish quality assurance plan adopted.

**7.3 Consequent to implementation of GST the following shall be furnished by the bidder:**

- i) Name, address along with the state name and GSTIN of the supplier.
  - ii) Name, address along with the State Name and GSTIN or UIN.
  - iii) Name and address of the recipient and the address of delivery along with the name of State and its code, if such recipient is un registered and where the value of taxable supply is fifty thousand rupees or more.
  - iv) Description of goods along with HSN code and services along with the SAC code.
  - v) Applicable GST i.e. CGST and SGST in case of local supply and IGST in case of inter-state supply. Applicable rate of GST also to be mentioned.
- 8.0** Tenderers shall not be under declaration of ineligibility for corrupt and fraudulent practices issued by the Government of Karnataka.

**9.0** The tender is of two part system.

The Bidder should upload scanned copies of the following documents.

**A. PART-I (Technical Bid)**

- a) Documents to meet the qualification criteria specified in NIT.

- b) The notarized declaration by the bidder that none of his contracts have been subject to forfeiture of EMD/foreclosure/termination of their Contract in KPCL/Government or any other utility and blacklisted for participating in tender by KPCL or Government or any other utility in India during the past five years (**Refer schedule-15**).
- c) Form of Bid (Annexure-A), Details of the Commercial terms and conditions, all the schedules specified in bid documents pertaining to commercial terms and conditions. All the technical details and drawings, etc of the technical offer along with all the technical particulars.
- d) The qualifying requirement as claimed by the Bidder(s) should be filled up in the format enclosed in Instruction to bidders **i.e., Bid evaluation format**.

**B. PART -II shall contain only Price Bid.** The date of opening of Part-II would be intimated in advance to those bidders who are qualified.

- 10.0** Bids submitted within the scheduled date and time shall only be eligible for further processing of the bids. Any bid submitted after the date and time specified shall be rejected even if it is accepted by the e-portal. Date and time stamp of the e-portal system shall be final in deciding the time of submission of bid. Decision of the Corporation in this regard shall be final and acceptable to all the bidders.
- 11.0** The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 12.0** Rates shall be quoted in price schedule ( **Schedule-3** i.e. Price bid) in the e-procurement portal only in the space provided for uploading **“FINANCIAL BID DOCUMENTS”**
- 13.0** Price bid (Part-2) of tenderers who have furnished all the documents to meet the qualification criteria, technically and commercially responsive will only be opened.
- 14.0** The tender shall be valid for **180 days** from the date of opening of Part-1 of the bid.
- 15.0** **COMPLETION PERIOD**  
Completion period is 24 weeks for both VIP lift and Freight lift of RTPS from the date of Letter Of Award (LOA) or detailed order whichever is earlier.
- 16.0** KPCL reserves the right to verify any information/documents furnished by the bidder should the circumstances so warrant. In case the information or the documents furnished are found to be incorrect/false or invalid, then the EMD furnished by such bidder shall be forfeited.
- 17.0** Corporation reserves the Right to reject any or all the tenders without assigning any reasons thereof. However, in all cases KTHPP act shall be followed.
- 18.0** Any other information required may be obtained from the office of Chief Engineer (Thermal Design) during office hours.

- 19.0** Bidders who have not obtained the user ID and Password for participating in e-procurement in Karnataka Power Corporation Limited may now obtain the same from the website (<https://eproc.karnataka.gov.in>).
