2. Tender documents may be downloaded from Government of Karnataka e-procurement website <https://eproc.karnataka.gov.in> under login for Contractors. After login to contractors, please scroll down to the right side bottom to see list of tenders, please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only interested contractors who wish to participate should remit online transaction fee for tender after registering in the portal. The tender processing fee is non-refundable.
3. Tender must be accomplished by Earnest Money Deposit which should be paid online through e-Procurement portal using any of the following payment modes.
- Credit card,
 - Direct debit,
 - National Electronic Fund Transfer (NEFT),
 - Over the Counter (OTC)
(Only through designated branches of ICICI Bank)
4. Tenders must be electronically submitted (Only through internet) within the date and time published in e-Procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, in the presence of the bidder who wish to attend at the Office of the Executive Engineer CCM, BTPS, Kudathini - 583 152, Ballari (Tq & Dist) Karnataka (State).

7. Eligibility criteria

- a) KPCL Class-II registered & above Contractors having adequate experience and fulfilling the **MINIMUM PRE-QUALIFICATION REQUIREMENTS** can bid for the tender.
- b) No joint venture/Consortium is permissible.
- c) Bidder shall not be under declaration of ineligibility for corrupt and fraudulent practices issued by the Government of Karnataka.
- d) None of the contracts of the bidder/company/individuals should have been terminated/foreclosed on account of his default elsewhere during last five years.
- e) The bidder should have following documents.
 - i. Income tax PAN.
 - ii. Independent PF code.
 - iii. GST registration certificate.

8. Minimum pre-qualification requirements

- a. The intending bidder should have executed at least one civil/similar nature of work costing not less than Rs. 18.73 Lakhs in any one of the last five years i.e., from 2014-15 to 2018-19. Scanned copies of work done certificate from officers of Govt organisation/ Dept. and public sector under taking/any other reputed organisation not below the rank of executive engineer/ competent authority should be furnished. **(Work done of previous financial years shall be given weightage of 10% per year to bring them to the price level of the financial year in which the tender is invited)**
- b. The average annual turnover of the agency should not be less than Rs. 37.45 Lakhs in any two financial years during the past five years i.e., from 2014-15 to 2018-19. Scanned copies of statement of accounts certified by chartered accountant should be enclosed as a documentary proof. **(Financial turnover of previous financial year shall be given weightage of 10% per year to bring them to the price level of the financial year in which the tender is invited)**
- c. The intending bidder shall upload the attested scanned copies of Contractor registration certificate, PAN, PF registration and GST registration number.

9. Technical & Financial bids:

The Bidder should upload the scanned copies of the following documents.

I (Technical bid)

- a) Documentary evidence for pre-qualification requirement mentioned in para no.8.
- b) The declaration by the bidder that EMD has not been forfeited & none of his contracts have been terminated/foreclosed on account of his default in KPC or elsewhere during last five years.
- c) Income tax PAN, Independent PF code, GST registration certificate.
- d) Declaration that bidder's offer has no conditions contravening the commercial conditions of the bid.
- e) The declaration by the bidder that the none of his contracts have been Terminated/foreclosed on account of his default in KPC or elsewhere during last Five financial years.

- f) Declaration by the bidder that he has studied the site conditions, labour conditions and read the bid documents and related matters carefully and diligently and that he has submitted the Bid having studied, understood and accepted the full implications of the agreement.

II (Financial bid)

- a) The original document should be produced for verification at any stage Of tender process as and when sought for, failing which, the bids are liable for disqualification.
- b) Rates shall be quoted in Tender Schedule – B (Financial Bid) in the web site itself.
- c) For those bidders whose Technical Bids satisfy the eligibility criteria and pre-qualification requirements criteria and who has furnished all the necessary documents, only those financial Bids will be opened.

10. General conditions

- i. The tender shall be valid for **180 days** from the date of submission of Tenders.
- ii. The tender document is part and parcel of the agreement.
- iii. Conditional Tenders will not be accepted.
- iv. KPCL reserves the right to verify any information/documents furnished by the bidder should the circumstances so warrant. In case the information or the document furnished is found to be incorrect/false or invalid then the EMD furnished by such bidder shall be forfeited.
- v. Right to reject any or all the bidders without assigning any reasons rests with the accepting authority.
- vi. The successful bidder shall give an undertaking that they would abide by the provisions of the Employee's Provident Fund Act.
- vii. The contractor shall obtain insurance coverage for all the workers working in this area.
- viii. The contractor shall quote his rates inclusive of PF and as per the applicable rates as issued by the PF department from time to time.
- ix. KPCL shall recover the Income Tax, GST, royalty etc., at the prevailing applicable rates.
- x. The bidder should maintain the register of labour deployed and the wages paid for the workers and shall produce the documents whenever called for by the competent authority and remittance towards PF shall commensurate with the labour component for the work involved.
- xi. The bidder should have independent PF code. The contractor shall remit PF of labours to contractor's permanent PF code number only and "not to the KPCL PF sub-code".
- xii. The contractor shall produce the ESI registration certificate if applicable and if the work awarded to them.
- xiii. The bidder shall quote his rates inclusive of GST and all other applicable taxes, levies, duties and Building Workers Welfare Cess at 1% etc., as per the latest GoK and GoI prevailing rules.
- xiv. Permit/royalty and other connected remittance to the Mines & Geology department, to allow for the utilization of soil/murum/sand..etc., required for the awarded work shall be obtained, if not, action will be taken as per the prevailing rules of Mines & Geology department.
- xv. If the contractor makes any alterations in the conditions of the contracts or puts any condition of his own, such tenders are liable for rejections.
- xvi. Tenderers quoting unreasonably low service charges or high service charges for any categories of service/items are liable for rejection.
- xvii. Contractor should follow the minimum wages act with respect to labour wages as issued by labour department time to time.
- xviii. In case the dates notified above are declared as holiday, the immediate next working day shall be reckoned.
- xix. Any other information required may be obtained from the office of the undersigned during office hours.

- xx.Any clarification in the uploaded documents in Technical bid is to be sought from the contractor for verification if it's necessary.
- xxi.Services to be provided by contractor and Cleaning Materials to be used per month are indicated in the **Annexure-I & II** of bid document.
- xxii.The work **specifications/scope/schedule** is given in the **Section-5** of Bid Document.
- xxiii.The tender document shall be available for download free of cost from date and time of publication of tenders on the KPPP till last date and time or the extend time.
- xxiv.Aspiring bidders/contractors who have not obtained the user ID and Password for participating in e-procurement in Karnataka Power Corporation Limited may now obtain the same from the website (www.eproc.karnataka.gov.in)
