- c. Tenders must be electronically submitted (Only through internet) within the date and time published in e-procurement portal. The Technical bids will be opened at prescribed time and date in the e-procurement portal.
- d. Amount put to tender as per departmental estimate is **Rs.89,76,445/- for one year.** Other details can be seen in the tender document.

## **II. Pre-Qualification Requirements:**

- i. The intending bidder shall be a NABL Accredited Registered Firm in the business of providing the services for "Sampling of coal from rake and moving belts, sample preparation & analysis of station coal and associated works. Suitable certificates to be furnished in this regard.
- ii. The bidder should have satisfactorily carried out at least one work in last 5 years in providing service for "Sampling of coal from rakes and moving belts, sample preparation & analysis of station coal and associated works in a Thermal Power Plant / processing industry of a single Work Order value of not less than Rs.45 lakhs. The Bidder shall submit the Work Order and Work done Certificate issued by the competent authority for having successfully completed the work as original/prime contractor along with the Technical bid. The value of completed works shall be given a weightage of 10% per year.
- iii. The intending bidder should have achieved a minimum annual turnover of Rs. 90 lakhs in any of the two financial years in the last five years. As a proof of turnover, he has to furnish financial report audited by Certified Auditor / Chartered Accountant of the financial years, 2014-15, 2015-16, 2016-17, 2017-18 & 2018-19 along with technical bid. Financial turnover of previous years shall be given a weightage of 10% per year.
- **III.** The intending bidder should have the following Registration with statutory Departments. Agency should furnish copy of Certificates along with technical bid. On demand Original shall be produced for verification.

- 1. Registration of Establishment/Firm/ Company/ Individual from Govt. department and Department of Labour.
- 2. PF Registration with Regional Provident Fund Commissioner.
- 3. GST Registration
- 4. PAN Card.
- **IV.** EMD of Rs. 1,80,000 /- (Rupees One lakh eighty thousand only) has to be remitted at e-portal only. EMD shall not carry any interest.
- V. A declaration has to be submitted by the bidder that none of his contracts have been terminated/foreclosed on account of his default in KPCL or elsewhere during last five years. The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- **VI.** For those bidders whose Technical Bids satisfy the eligibility and prequalification requirements criteria and who has furnished all the necessary documents, only their Financial Bids will be opened.
- **VII.** KPCL shall recover the Income Tax, GST etc. at the prevailing applicable rates. No reimbursement of GST shall be made by KPCL. Bidders shall submit proof of remitting GST.
- VIII. Performance Guarantee: For the due and faithful performance of the Contract, the successful bidder shall provide 5% of the total contract amount plus additional security towards unbalanced tender towards Performance Guarantee in the name of DGM (F) BTPS in the form of Bank Guarantee (on a non-judicial stamp paper of Rs.200/-) as per KPCL pro-forma from any nationalized/scheduled bank (on Applicable stamp paper)/ TDR / FDR / Cash certificate, valid for a period of 18 months from the date of commencement of the work, within 20 days from the date of issue of Letter of Award. If the agency fails to attend any of the problems pertaining to Scope of Work, the Performance Guarantee will be forfeited till the completion of the work.
- **IX.** The successful bidder shall enter into Agreement with KPCL for carrying out the work at the terms & conditions of the tender within 20 days from the date of letter of Award (Work Order). Agreement shall be signed on non-judicial stamp paper of value Rs. 200/-.

- X. All pre bid enquiries are to be sent before the pre-bid meeting. All intended bidders are requested to get their doubts cleared and clarifications received from BTPS on or before 18.03.2020 up to 1600Hrs. A Pre bid meeting will be convened on 20.03.2020 at 1100Hrs at AGM(C) FM office at BTPS Kudathini, Bellary Dist. All interested parties are requested to attend.
