Tenders in two covers are invited through "e" procurement portal (Website URL:<https://eproc.karnataka.gov.in>) for the Supply of 01 no. new 50HP Submersible pump set to BRP, KPCL, Jog falls, Karnataka on FOR destination basis from reputed Manufacturers/Authorized dealer with proven track record of having supplied the similar materials earlier.

1. Tender documents may be downloaded from Government of Karnataka e-procurement Website URL:<https://eproc.karnataka.gov.in> under login of bidders. After login, tender document can be downloaded from the portal within prescribed date and time published in the portal. Interested bidders who wish to participate should remit online transaction fee for tender after registering in the portal. Tenders must be electronically submitted (on-line through internet) within the due date and time published in e-procurement portal.
2. Earnest Money Deposit (EMD) of **Rs. 7,750/-** (Seven Thousand Seven Hundred and Fifty Only) and tender processing fee should be paid online through e-procurement portal using any of the payment modes like Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC). The transaction fee is non-refundable
4. **THE BIDDERS SHALL HAVE THE FOLLOWING PRE-QUALIFYING REQUIREMENTS:**
 - a) The intending bidder shall be the Manufacturer/Authorized dealer and shall have proven experience in the field of manufacturing/supplying of reputed make 50HP single stage submersible pump set to central/ state Govt./PSU's or any reputed organizations. In proof of the above, purchase order/ work order and work completion certificate of single order of similar supply with the contract value not less than Rs.1.55 lakhs in any one of the last 05 financial years (i.e., 2014-15, to 2018-19) issued from the competent authority should be furnished.
 - b) The Bidder in the last five financial years i.e., 2014-15, 2015-16, 2016-17, 2017-18 & 2018-19 should have achieved in at least two financial years an average annual financial turnover not less than Rs.3.10 lakhs. In proof, Annual Reports / Turn over certificates duly certified by the Chartered Accountant shall be furnished. (Financial turnover of previous years will be given weightage of 10% per year to bring them to present price level).
 - c) The Bidders shall have PAN no. and GST certificates. In proof, PAN no. and GST certificate copies shall be furnished.
 - d) The bid of the bidders whose contracts have been terminated/ foreclosed in KPCL or elsewhere during last 03 years and also those who do not meet the above pre-

qualifying requirement will be rejected. The declaration duly signed in the prescribed format has to be enclosed.
